Dear Planning Commissioners:

I represent Integral Communities, the developer of the proposed mixed use development at the former Mervyn's headquarters located at 22301 Foothill Boulevard.

Integral Communities is very proud of our tradition of community engagement. Towards this end, our outreach team has secured over **460 signed endorsements** from Hayward residents confirming support for our development. On Saturday, November 1, our outreach coordinators conducted a door knocking campaign in the Prospect Hill neighborhood. This door knocking campaign has produced the following results thus far:

- 81 door "knocks"
- 28 residents answered the door
- 18 residents signed our petition in support of the development (that is 65% of residents we spoke to favored our project)
- 9 residents committed to writing a letter of support for our development
- 4 residents committed to speaking out at the upcoming council hearing

These initial results provide strong evidence for overwhelming support for our development among not only Prospect Hill residents but the majority of the citizens of Hayward that we were able to talk to. These results contradict testimony from the two Prospect Hill residents at the Planning Commission hearing on October 17 and affirms that there is significant support from the neighbors of this shuttered office building.

In addition to our door knocking campaign, our team has already received **24 formal letters of full support** from the following influential members of the public, including residents, public officials, and downtown business owners:





On behalf of the Hayward Chamber of Commerce I would like to express full support for the proposed redevelopment of the former Mervyn's Headquarters at 22301 Foothill Blvd. by Integral Communities. Additional households from this new modern development will have a significant positive impact on downtown.

The chamber has worked closely with Integral Communities since early 2012.
